 - B. During our audits, it was found that on July 16, 2024, the Village Board adopted the proposed pay scale for FY 2025-2030 as approved by the Administration Committee on July 9, 2024. Within that pay scale, it states employees shall be given a bonus for every five years of service. A \$1,000.00 bonus will be issued to employees for every 5 years of service to the village. Village President Hintz authorized Director Gottwalt’s retroactive bonus of \$5,000.00 on July 18, 2024, for his 25 years of service. The authorization of the bonus retroactive pay was issued via direct deposit. It is under the advisement of our auditors that the Village Board acknowledge and ratify Village President Bill Hintz’s authorization to issue said funds to Director Gottwalt, as it was not clearly stated in the Board Minutes as being part of the approved Bills, Payroll, and Transfers. It was also advised that future bonuses should be issued through payroll rather than via direct deposit, as recommended by our auditors, to ensure that the proper taxes are withheld and remitted to the appropriate state and federal authorities.
