VILLAGE OF CARBON CLIFF, ILLINOIS
NOTICE OF INTERESTED PARTIES REGISTRY
(Carbon Cliff Redevelopment Project Area)

Pursuant to Section § 5/11-74.4-4.2 of the Tax Increment Allocation Redevelopment Act, 65 ILCS § 5/11-74.4-1, *et seq.* (the "*Act*"), the Village of Carbon Cliff (the "*Village*") has established an interested parties registry ("*Registry*" or "*Registries*") for a proposed redevelopment project area to be known as the Carbon Cliff Redevelopment Project Area (commonly known as the "*Carbon Cliff TIF*"). The Village has adopted an Ordinance establishing interested parties registries and registration rules for tax increment financing redevelopment project areas.

I

The proposed Carbon Cliff TIF is approximately 238 acres within the Village's boundaries adjacent to John Deer Road, near Megan Drive, along 2nd Avenue near 3rd Street, and parcels east of 10th Avenue.

Any resident of the Village and organization active within the Village are entitled to register in the Registry to become an "Interested Party" for the proposed Carbon Cliff TIF. Organizations include, but are not limited to, businesses, business organizations, civic groups, not-for-profit corporations, and community organizations within the Village or the proposed area of the Carbon Cliff TIF. The Registry will include the name, address, and telephone number of each Interested Person and, for organizations, the name and phone number of a designated contact person.

Individuals and organizations wanting to register as an Interested Party with respect to the Carbon Cliff TIF must complete and submit an Interested Parties Registration Form with the Village Clerk. The registrant must submit a copy of a current driver's license, lease, utility bill or such other evidence that may be acceptable to the Village Clerk to establish the individual's current residency. If the registration form and/or supporting documentation are incomplete, the Village Clerk will give written notice of a defective application to the registrant. The registrant will be entitled to correct any defects and resubmit a new registration form and supporting documentation.

Registered residents and organizations will be entitled to receive notices of public meetings, public hearings, and the availability of redevelopment plans and eligibility reports.

EXHIBIT B
TIF INTERESTED PARTIES REGISTRY REGISTRATION RULES AND FORM

Establishment of Registry. The Village of Carbon Cliff hereby establishes an Interested Parties Registry for each Redevelopment Project Area, whether now existing or hereafter established. The Village will establish a new registry whenever it has identified an area for study and possible designation as a Redevelopment Project Area.

Maintenance of Registry. The Registry will be maintained by the Village Clerk. In the event the Village Director determines that an official or employee other than the Village Clerk should maintain the Registry, the Village Director may transfer the responsibility for maintaining the Registry to the other official or employee; provided that the Village Director: (i) provides at least 45 days prior notice to the Village Board; (ii) gives prior written notice to all Interested Parties not less than 30 days prior to such transfer; and (iii) publishes notice of the transfer in a newspaper of general circulation in the Village.

Registration Process. Individuals and organizations wanting to register as an Interested Party with respect to the Carbon Cliff TIF must complete and submit this Interested Parties Registration Form and submit to the Village Clerk, at the following address:
